CSIR – Central Food Technological Research Institute, Mysuru a constituent national laboratory of council of Scientific & Industrial Research Institute (CSIR), invites applications from eligible candidates for recruitment of 2 (Two) positions of Project Assistants Level II initially for a period of One year or till the project is over on a temporary contractual basis in the project entitled “**Microbial and pesticide decontamination of freshly consumed vegetables**” (GAP-0519) funded by LSRB (DRDO), tenable at the Fruit and Vegetable Technology Department, CSIR-CFTRI, Mysore, Karnataka.

Essential Qualifications:

First class M.Sc./M.Tech in Food Science/Food Technology/Biotechnology/Microbiology or equivalent degree with good academic records. Work experience in the project related area will be given priority.

Emoluments:

Rs.12,000/-per month (Rupees Twelve Thousand only) consolidated.

1. Candidates should not have exceeded **28** years of age as on **03.11.2017** i.e. the last date of receiving the applications. Age relaxation as applicable by Gov. of India rules for SC/ST/OBC and women candidates will be considered.

3. The engagement will be contractual and on purely temporary basis for a maximum period of one year or co-terminus with the project, whichever is earlier.
