CSIR– Central Food Technological Research Institute, Mysore is a premier National Institute of the Council of Scientific & Industrial Research, New Delhi. CSIR–CFTRI is committed to excel in Research & Innovation, Knowledge Dissemination, Technology Transfer and Human Resource Development in the areas of Food Science, Technology and Engineering through quality attributes to be practiced and implemented at all levels. The focus of research & innovation in diverse disciplines of food science, technology and engineering is very well supported by excellent infra-structure, state-of-the-art instrumental and pilot plant facilities and advanced research training.

A walk-in-interview will be conducted at CSIR-CFTRI, Mysuru at the above address on 11 May, 2017 to select candidates for engagement of two JRF-GATE fellows under CSIR's Junior Research Fellowship (JRF) GATE scheme for Indian nationals to work at CSIR-CFTRI with modern infrastructure facilities on contemporary research projects and obtain Ph.D. degree from AcSIR. The interested candidates may visit the Institute website (www.cftri.res.in). The candidates may apply for admission for Ph.D. programme for August 2017 session against the advertisement published by AcSIR CSIR-CFTRI. The candidate may visit AcSIR website <http://acsir.res.in> for detailed information and apply online for Ph.D. admission.

Eligibility: B.E/B.Tech degree holders in Chemical Engineering/ Food Technology/ Food Processing Engineering/Mechanical Engineering with a valid GATE score and desirous to pursue full time Doctoral (Ph.D.) Research Programme in Engineering Science under Academy of Scientific & Innovative Research (AcSIR).

Who are not eligible: M.Tech candidates (either with B.Tech/ M.Tech or with M.Sc/ M.Tech) are not eligible for this fellowship. All those eligible for direct CSIR-SRF cannot apply for this fellowship.

Age limit: The upper age limit for JRF shall be 28 yrs which is relaxable up to 5 years in case of candidates belonging to Scheduled Castes/Scheduled Tribes, women, physically handicapped and OBC applicants.

Stipend and tenure: The fellowship is to be given to a candidate for a total duration of five years within which the candidate is required to complete the PhD degree. This fellowship amount is Rs. 25,000/- plus HRA per month. In addition, contingency grant of Rs. 20,000/-

per annum (calculated on pro rata basis for fraction of a year) is available to each fellowship as per the CSIR guidelines.

Further on completion of two years as JRF-GATE, the fellowship may be upgraded to SRF-GATE and stipend may be increased to Rs. 28,000/- per month in the subsequent years on the basis of assessment as per normal CSIR rules. All other conditions of JRF-NET will apply.

Candidates selected for the award of JRF-GATE will be eligible for fellowship subject to getting registered/enrolled for Ph.D.

The interested candidates may appear before the selection committee with all their original certificates/ mark sheets with an attested photo copy of each of it and a recent passport size photograph along with the filled-in application form as in **Appendix-1**
