CSIR – Central Food Technological Research Institute, Mysuru a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of 1 (one) position of Project Assistants Level-II initially for a period of one year or till the project is over on a temporary contractual basis in the project entitled “**Understanding the mechanism of polyunsaturated fatty acid accumulation in chia (*Salvia hispanica*) seeds**”(GAP-0507) funded by SERB, New Delhi tenable at the Department of Lipid Sciences, CSIR-CFTRI, Mysore, Karnataka.

Essential Qualifications:

First class M.Sc./ M. Tech. in Biochemistry/Biotechnology/Molecular Biology/Life Sciences or equivalent degree with good academic records.

Desirable, if any: Experience in lipid metabolism, protein purification, enzymatic assays and molecular biology.

Emoluments:

1. Candidates should not have exceeded **28 years** of age as on **16.04.2017** i.e. the last date of receiving the applications. Age relaxation as applicable by Gov. of India rules for SC/ST/OBC and women candidates will be considered.
